WASH AND WEAR AGAIN

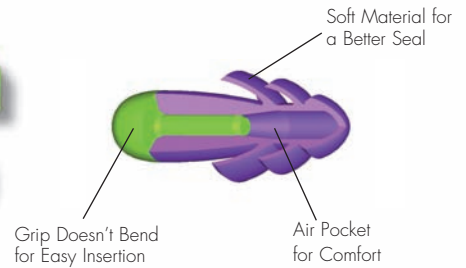
